

Overview

In response to the always increasing new cases of HIV/AIDS, WOW! /J4L has founded the **Hope for Our Youth (HFOY)**, HIV/AIDS National Awareness Campaign. This national HIV/AIDS awareness campaign was founded because we believe that in the U.S., complacency has set in regarding HIV/AIDS. Many people believe that because medical technology has progressed to a point where infected people can live longer, HIV/AIDS should no longer be a priority in the US.

Students United in Keeping the Promise HIV/AIDS Awareness Poetry, PSA Treatment & Dramatic Arts Piece Competition (SUKP PPTDAC), sponsored by WOW! Productions Inc., Alameda County Public Health Dept. Office of AIDS, and the J4L Foundation, is a competition that provides a platform to creatively explore issues that surround HIV/AIDS in the areas of education, prevention and testing among youth in our community. The winner's creations from all three genres will be used in conjunction with all of the HFOY, HIV/AIDS National Awareness Campaign resources.

The students will become directly involved in making a difference in their immediate circle of friends, family and neighbors within their community. The SUKP PPTDAC will raise the awareness of this pandemic of HIV/AIDS and alert the community of the issues our youth are facing in the wake of new cases of HIV in the city of Oakland and within the demographic of 14 - 24 year olds.

The competition seeks to encourage students to find and use their voice by conveying a fresh approach with culturally unique storylines, ideas and situations that encompass HIV/AIDS issues within their world. Entries are due by **May 2** and will be carefully reviewed by a prominent panel of judges. The winners will be announced on **May 18** and will receive Poetry- Laptop computer, PSA Treatment – Mini Camcorder and Dramatic Arts Piece – Portable DVD Player.

The mission of **Student's United in Keeping the Promise**, **Contest & Education/Prevention Testing Rally** is to raise the general public's awareness of the most recent data concerning HIV/AIDS in their community. In doing so, we fall inline with the Alameda County Public Health Department's Health Status Report, 2006 goals.^a With rapid changes in the number of new cases of HIV/AIDS in the African American population the need for education/prevention has never been greater. Competition Rules

HOW TO ENTER

This competition is open to legal residents of the United States (excluding Puerto Rico). The competition is reserved for students (grade 9 thru grade 12) enrolled in an accredited high school in Alameda County. DETERMINATION OF WINNER

The Selection Committee made up of prominent members of the African American creative and artistic community, African American leaders and HIV/AIDS experts will select the winners from the six (6) finalists. The selection process shall be conducted under the supervision of the Sponsors. Sponsors shall choose the winner based on their creativity to evoke a fresh and culturally unique angle on the issues in a way that resonates with the youth. Sponsors and the Selection Committee shall select the winners at their sole discretion.

Treatment for PSA

Write a treatment (summary of story) of the Public Service Announcement. Your topic should center on HIV education, prevention and or testing. The summary should be a maximum of 1000 words DOUBLE spaced on two pages, **NO** more than two pages. **NO** vulgar language is allowed. Use of vulgar language will result in immediate disqualification. The treatment should create a 2 minute piece.



Dramatic Arts Piece

The topic of this piece should focus on the situations surrounding HIV/AIDS education, prevention and testing. The piece should be from 5 – 10 minutes long, use the standard three (3) ACT play format, DOUBLE spaced. Absolutely **NO** vulgar language will be tolerated, use of will result in immediate disqualification.



Poetry Guidelines

The topic of each poem should reflect on a situation dealing within the parameters of HIV/AIDS education, prevention and testing. Absolutely **NO** vulgar language will be tolerated and will result in immediate disqualification. All poems must be 3 - 5 minute presentation typed 1 page DOUBLE spaced.

Write a brief essay explaining why you want to enter this competition, how your Poem, PSA treatment or Dramatic Arts Piece might impact the AIDS epidemic in America and why audiences will want to see your work. Please include any information about what has inspired you to pursue this subject and or how you have been touched by HIV/AIDS. This summary should be a maximum of 800 words and or one page.



Frequently Asked Questions

1. What is the deadline for submitting applications?

May 2, 2007. Applications postmarked after May 2, 2007 will be disqualified from the competition. There is no need to "overnight" or "priority mail" your application as long as the package is postmarked on or before May 2, 2006. However, because the competition committee is not responsible for applications that are lost in the mail, registered or certified mailing is encouraged.

2. When/Where will the Competition winner be announced?

Six (6) finalists will be announced on May 9, 2007. One (1) winner will be announced from each genre on May 18, 2007. Winner will be announced during the performance assembly at Castlemont Communities of Small Schools, and the WOW! Productions, Inc., My Space page website, (www.myspace.com/wowproductionsinc). Winner must return a signed Letter of Prize Acceptance, Waiver of Liability, License Agreement and certain other documents required by Sponsors within ten (10) days of notification or they will forfeit their prize and an alternate winner will be chosen. These documents will be sent to the winner at the address listed on the application cover page.

3. May more than one person submit poem, PSA treatment Dramactic Arts Piece as a collaborative effort?

Yes. Writer-Director teams are welcome to apply as a group. However, each member of the 'team' must be listed on the application and on the support documents. Only ONE contact person and address should be listed for notification.

4. Will application materials or support documents be returned to applicants?

No. The competition will not return poems, PSA Treatments, Dramatic Arts piece, or any additional information submitted by applicants. It is the sole responsibility of the applicant, therefore, to keep copies of any and all submitted material if they would like to have a copy for their records. If our panel does not select your submission, we encourage you to try to produce it on your own.

8. How long should a treatment for a Public Service announcement (PSA) be?

For a 5 - 10 minute PSA, the treatment, for this competition should be between 2 - 5 pages.

9. Must the concept be my own original idea or can I get the 'idea' from another source? The story, screenplay, or treatment MUST be original and the intellectual property of the applicant(s).

10. Can I submit a Storyboard along with my other application items?

Yes. Though it is not required to submit a storyboard with your application, any submitted material that can offer the selection committee more information regarding your 'vision' for the PSA treatment is welcome.

11. What exactly is a "treatment?"

A "treatment" is a written narration of the plot points of a screenplay. It describes the story from its beginning to end, much as someone would convey their script in a verbal conversation. Although it varies in length, for the purposes of the Competition, it is from two to five double-spaced pages.

The following is expected of a treatment:

- 1. 1. It is told in the present tense.
- 2. 2. All characters' names are written in BLOCK CAPS when they are first introduced.
- 3. 3. It rarely contains dialogue, unless germane to the story.

4. 4. It chronicles the first, second and third acts of the story (approximately one act per page), including the key turning points and the resolution, but does not label the acts.

Examples of film treatments can be found online, or at your local library or bookstore.

12. Why do I have to submit a "resume" or "bio?"

Resumes and bios are required for two reasons.

- 1. To help the Jury evaluate your ability to complete the project, and
- 2. To provide information about the winner for press purposes.

13. What if I don't have a "resume" or "bio?"

A resume or bio MUST be submitted with the application. Do your best to formulate some sort of resume or bio to go along with your application that indicates your work and educational experience, particularly any experience associated with studying film or actual filmmaking. If you are submitting an application as a "team" or a "group," ALL members of the team should submit separate resumes/bios. If you are submitting an application as a class, then your teacher/professor must submit her/his resume and bio.

14. What should I write in my "Statement of Purpose"?

Your personal statement should give the selection committee insight into why you entered the competition, and why it would be important to you to be able to be a part of making a short film on AIDS and Black communities in America.

16. Can applicants submit more than one poem, PSA treatment or Dramatic Arts Piece for consideration? Yes. But, you must submit a completely separate application packet for each idea.

18. Do I need to submit copies?

Yes, a completed application package must include one (1) original and five (5) copies of all requested documents.

19. How are the winner selected?

A judging committee made up of prominent members of the creative and artistic community along with noted TV personalities, authors and performers, and leaders and HIV/AIDS experts will then select one (1) winner in each genre.
